ABILITIES:


 **SUCK**
(Damage done by this animal is added to your player's life total.)

 **VIGOR**
(Can BOTH attack and block during a single turn.)

 **RUSH**
(Can attack as soon as this animal enters the battlefield.)

 **SAVAGE**
(Attacks TWICE, with the first attack unable to be countered.)

 **ATTACHED**
(Unable to move. It can only block, not attack.)

 **ENTANGLE**
(Can block animals with FLYING and removes FLYING when it does so.)

 **BURROW**
(Can only be blocked by underground animals.)

 **FLYING**
(Can only be blocked by animals with FLYING or ENTANGLE.)

 **DIVIDE**
(When this animal dies, it creates 2 SPAWN versions of itself.)

 **HIDE**
(If hidden animal defeats an opponent, it takes no damage.)

 **LETHAL**
(Destroy any animal that this animal damages.)

 **OVERPOWER**
(Attack damage beyond what is blocked goes to opposing player.)

 **PERCEIVE**
(HIDE ability and TRAPS do not work against this animal.)

 **POUNCE**
(May directly attack an enemy animal instead of player.)
